1.6 BID QUESTIONS

- Q1: Note 6 on G-002 calls for owner to abate floor tile and remove and store all casework.
 - a. Floor appears to be painted? Please clarify.
 - b. Is casework/rolling tables/countertops that are to be demoed per notes on 2/A-103 completed or is that to be in our scope of work
- A1: The owner has abated the floor tile and painted the existing concrete floor.
 - a. Floor paint to be removed and the existing concrete floor is to be patched and sealed per the revised specification 033543 CONCRETE REFINISHING.
 - b. All casework/rolling table/countertop (items) have been removed from the area of work and stored in the basement of an adjacent building on campus. The contractor is responsible for moving the stored items back into the work area, pending the acceptance of ADD ALTERNATES noted on the drawing. If the ADD ALTERNATE is accepted, the contractor is responsible for disposing of the stored (items).

- Q2: Drawing A103 notes 6,18 calls for reusing countertop but elevations on A-900L calls out new epoxy resin top and backsplash in elevations. Please clarify.
- A2: No countertops are to be salvaged and reused. Sheet notes 3,6, 14, and 18 on revised sheet A-103.
- Q3: Could you provide details and a rough size of the owner-stored projector screens? I.E. wall mt'd, ceiling mt'd, recessed, etc
- A3: Wall mounted 5'h x 8'w. See photo P-8 on 2/A-401.
- Q4: Could an elevation be provided for the casework label Add Alt 01 outside office 308?
- A4: No elevation needed vendor to provide (3) 36" wide door base cabinets, (1) 24" wide single door base cabinet, and 10 linear feet of wall shelving above. Wall shelving to have (2) adjustable height shelving units. Provide a new epoxy top and backsplash. No change to any existing power or data outlets.
- Q5: Are we to supply stools on 8,9 &10/A-900L? Is there a specification?
- A5: No, provided by owner.
- Q6: Do details 3,6,9 & 10/A-900L receive new epoxy resin tops?
- A6: YES
- Q7: Is the equipment listed on A-912L new or salvaged? Is it in our scope?
- A7: EXISTING EQUIPMENT BY OWNER. CONTRACTOR TO INSTALL PER THE DOCUMENTS, UNO.
- Q8: If alternates ADD #1 and/or #3 are accepted are we responsible to dispose of the existing stored material?
- A8: YES
- Q9: It is my understanding that the existing 2' x 4' ceiling grid will remain, and we will be adding 2' cross tees to adapt it to a 2' x 2' system only to accommodate your owner-provided 2' x 2' lights. However, the finish schedule on Dwg A-501 shows APC-01 as 2' x 4' while Spec 095113 states a 2' x 2' tile is required. Please confirm.
- A9: APC-01 will be changed from 2'x4' to 2'x2'.
- Q10: Is there any work required in Lab 302? If so, please describe.
- A10: NO.
- Q11: How do we refinish the existing wood casework to be reused?
- A11: Remove all labels and residue from wood cabinets. Fill all gouges/nicks in exposed wood surfaces with color-matching fill and stain. Laboratory wood casework is typically factory-finished using a chemical-resistant finish system
