In addition to these GCs, we also had representatives from Local 33 in attendance.

## Lombardi Development asked the following questions:

- 1. Note 6 on G-002 calls for owner to abate floor tile and remove and store all casework.
  - a. Floor appears to be painted? Please clarify
  - b. Is casework/rolling tables/countertops that are to be demoed per notes on 2/A-103 completed or is that to be in our scope of work?
- 2. Drawing A103 notes 6,18 calls for reusing countertop but elevations on A-900L calls out new epoxy resin top and backsplash in elevations. Please clarify
- 3. Could you provide details and rough size of the owner stored projector screens? I.E. wall mt'd, ceiling mt'd, recessed, etc?
- 4. Could an elevation be provided for the casework label Add Alt 01 outside office 308?
- 5. Are we to supply stools on 8,9 &10/A-900L? Is there a specification?
- 6. Do details 3,6,9 & 10/A-900L receive new epoxy resin tops?
- 7. Is the equipment listed on A-912L new or salvaged? Is it in our scope?
- 8. If alternates ADD #1 and/or #3 are accepted are we responsible to dispose of the existing stored material?

### Grae-Con asked the following questions:

- 1. Are the lab sinks integral to the new countertops?
- 2. Is the countertop supplier providing faucets, grid drain p-trap, etc. for the lab sinks?
- 3. If we are to provide the faucet, is there a specific manufacturer or model that you want us to provide?
- 4. Are the new lab hoods by the college, we are to connect the new lab hoods to the existing exhaust ductwork.
- 5. Is there a basis of design for the grilles and diffusers installed in the ceiling? If so, who is the Manufacturer and what is the model?

- 6. Is any air balance work required?
- 7. Sinks that are getting removed and not replaced, are we to cap the water and drain piping below the floor?
- 8. Is this project prevailing wages?

#### Waller asked the following questions:

- 1. Please advise how the painted floors are to be handled./
- 2. It is my understanding that the existing 2' x 4' ceiling grid will remain, and we will be adding 2' cross tees to adapt it to a 2' x 2' system only to accommodate your owner provided 2' x 2' lights. However, the finish schedule on Dwg A-501 shows APC-01 as 2' x 4' while Spec 095113 states a 2' x 2' tile is required. Please confirm.
- 3. I believe I heard someone mention that we did not have any work in that room. Is there any work required in Lab 302? If so, please describe.
