A cover letter was attached to the application that stated the following: *"The Classified Staff at West Liberty will be selling raffle tickets to raise money for scholarships for students attending West Liberty. Based on the results above, there will be a vacancy for Group 1 and Group 4 beginning July 1<sup>st</sup>. Please contact Bo McConnaughy if you are willing to become a representative for your Group. The group listings can be found on the website.
