4. FIRST AID MEASURES

First Aid Measures

General advice If symptoms persist, call a physician.

Eye contact Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. If symptoms persist, call a physician. Immediately flush with plenty of water. Pick up and transfer to properly labeled containers. Sweep up and shovel into suitable containers for disposal. After cleaning, flush away traces with water. Take precautionary measures against static discharges.
