 - Key Takeaways:

 - Signs have been approved; signs need pictograms – working on files; language has been approved; gold signs with black writing for normal usage; red signs with white writing for temporary usage; need more signs than originally planned
 - Residence Halls: Determined by housing (Krise + Rogers) for gun safes; one in the basement of Shaw – camera footage; cannot see face of person walking in; union is a problem – original room identified; Aladdin storage and dry wall which can easily be penetrated – other potential options for storage areas in the union; Joe Mills will be contacted for appropriate procedure to identify areas; off limit areas for storage: Mailroom
